Al Hamad Building Contracting Company L.L.C (HCC) has been on the forefront of the construction industry since 1985 and has the capability to carry out Design, Execution and Maintenance of both conventional & turnkey construction projects. HCC consists of in-house Design Department as well as Specialist Construction Divisions, which involve the Design, Development & Execution of the latest construction technologies.

The company established an internal MEP and Structural Division Departments which enables the control of all aspects of the construction process. Our MEP Department is an integration of Mechanical, Electrical and Plumbing Department that provides comprehensive services commencing from Design, Installation to Commissioning. Pioneering in its own league, the department provides cost-effective and innovative solutions and products for projects such as Hospitals, Newsrooms, Commercial & Residential Buildings, Auditoriums, Schools, Industrial projects, Hotels & Leisure Amenities, etc.

HCC's In-house MEP Department is managed by the MEP Director and includes various divisions such as Mep Design, Estimation, Execution, Maintanance, Quality Control, Testing & Comissioning, HVAC, Plumbing, Structural Cabling and Electrical Departments.

The functions of various MEP Divisions are outlined below:

MEP Design Team operates under the MEP Design Manager with HVAC, Electrical and Plumbing Design Engineers, Structural Cabling Engineers, Estimation Engineers, Draftsman and Quantity Surveyors. Designs which obligate the scope of HCC will be executed in-house to meet the conceptual requirements of the clients with appropriate number of proposals. All the design stages will be executed as per the agreement with the client, i.e. Design Review, Verification and Validation. Upon the completion of the proposal, it shall be forwarded to the consultant for final review and approval. The shop drawings will be prepared only after the completion and approval of Design, shop drawings for Mep will be issued from the Design Department to the site and registered in the output drawing, thus forwarded to the consultant for approval using submittal form. Our experts at site shall be maintaining workshop drawings schedule register as well as contract drawing register to keep track of the drawings.


The execution of MEP services is carried out by Five of our Project Managers. Each MEP Project Manager is assigned a project in nearby locations for less travel distance to ease communication and transportation of our manpower resources, tools and machineries Each Project Manager will consist of the following subordinates: HVAC, Electrica & Plumbing Engineers, Foremen, Draftsmen, Gangers, Technicians, Store keepers, Helpers, etc. Moreover, each projects has its own HVAC, Electrical and Plumbing Engineers with supervisory workforce provided from the above pool of resources. If there is a need for recruiting additional workforce it will be provided upon demand taken from other completed projects through the approval of the management.

Design and Development:

The company has established and maintains a procedure to ensure that design activities are completed and verified in accordance with the contract requirements.

Design and Development Planning:

Design plan will be established identifying the responsibility for each design and development activity. Design plan will be updated as the design evolves. The design and verification activities are assigned to qualified personnel equipped with adequate resources. Design plan will define organisational and technical interfaces between different groups involved in the design process.



Design and Development input:

Design input will be identified, reviewed for adequacy and documented in the plan. Incomplete or conflicting requirements will be resolved by delegated design personnel.

The input shall include:

- · Functional and Performance requirements
- · Applicable Statutory and regulatory requirements
- · Information derived from previous similar design, if any.

Design & Development Outputs:

Design output shall be expressed in terms of requirements, calculations and analysis and identified in the design plan. Design output shall meet design input requirements, make reference to acceptance criteria, comply with statutory requirements and refer to those characteristics that are crucial to the safe and proper functioning of the product.

Design and Development Review:

Design review will be performed as indicated on the plan in order to: Evaluate the ability of the results of design and development to meet requirements. Identify any problems and propose necessary actions. The results of review shall be documented.

Design and Development Verification:


Design verification will be performed by competent personnel in accordance with the plan and documented. Verification shall ensure that design output met design input requirements. Method of verification is specified in the design procedure.

Design and Development Validation:

Design validation is performed to ensure that the product conforms and fulfils the defined user needs and specified design requirements under specified operating conditions. Results of design validation will be recorded.

Control of Design and Development Changes:

Design changes or modification to the approved design shall be identified, documented, reviewed, verified, approved and validated prior to implementation. The review of changes shall include evaluation of the effect of the changes on the product.



HCC's MEP Workshop provides fabricated ducts, supporting frames, supporting structures and any necessary enhancements required at site as temporary or permanent as part of the MEP services. Our MEP Workshop functions under one of our Fabrication Foreman who ensure all process on site is made as swiftly as possible bounding the objectives of the client requirements.

Our MEP Maintenance Division is part of HCC's overall Maintenance Department which operates directly under our MEP Department complying with our guidance and technical skills. Once a project is awarded the Maintenance department shall receive instructions from our Execution team in coordination with the Testing & Commissioning team and will be held responsible for the maintenance of the project throughout the One Year Warrenty Period and will be in direct contact with the client during the One Year Warrenty Period for any required assistance. To control the quality and avoid defects the Maintenace team shall be coordination with our Execution team from the early stages of the project to ensure that all equipments and control devices are properly installed and maintained.

Our MEP Estimation team along with the HVAC, Electrical & Plumbing Estimation Engineers and Quantity Surveyors function directly under the MEP Deputy Director. The Estimation teams performs funtions such as estimation and MEP services for projects under tender and coordinate with HCC's Main Tendering Department for Tender and Contracts submittal. Moreover, functions such as Job Cost Analysis is performed by our MEP Estimation Engineers who aid our Cost Control Department.


Our MEP Testing & Commissioning team performs functions such as the Testing & Commissioning of various systems of all MEP Services under the guidance of and coordination with the consultant ensuring the project is handed over to the client with the proper functionality of all systems carried out. Apart from Testing & Commissioning our teams constantly coordinate with our Execution teams to ensure proper installation and maintenance is carried out. Functions such as 3rd party Testing & Commissioning are performed by our teams as per the specific contract requirements as well as coordinating with the special equipment manufacturers their equipment commissioning at site.

HCC's MEP Department has been operating for over thirty years and has diversified into other categories such as obtaining experience in the Green Building Requirements related to MEP Services.


MEP Division Timeline
